1. Arrears as per G.O.(P) No.2/2017/Envt. dated 04.11.2017 shall be remitted to the Board on receipt of this consent.
2. Condition 5.5 is modified as:Bio-Medical waste generated in the hospital shall be disposed through the common biomedical waste treatment facility, IMAGE at Palakkad.
3. Item no.5 in condition 4.1 stands cancelled.
4. Online monitoring facility shall be provided at treated effluent discharge point to evaluate the quality and the same shall be connected to Board's server.
5. The usage of plastic bottles for supply of drinking water shall be stopped. Provide facility for safe drinking water in glass bottles in place of plastic bottles on or before 15-12-2018.
6. Water purification/treatment plants/RO plants and glass bottle sterilisation units shall be established within the premises for the compliance of condition no (5).

All other conditions of the Integrated Consent to Operate issued as per reference above remain unchanged.
